Attended by more than a thousand people, the eleventh annual Accountancy Age Awards night was a resounding success



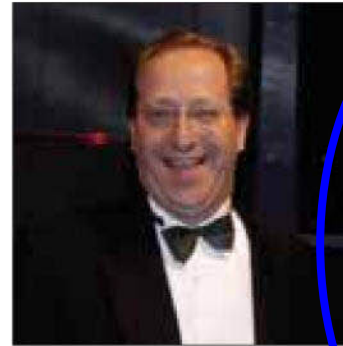
